MATTERS ARISING

The Day Centre, Llanidloes The clerk read out two replies to a letter sent in June received from Russell George AM and Glyn Davies MP/AS to Councillors and these were discussed. No reply had been received from Clr. Mayor Portfolio Holder to date.

Concert Clr. A.K. Davies informed Councillors that the cost of hire of the Community Centre had been raised to £150.00. It was agreed the cost of the tickets would be £8.00 and the clerk would print them. Clr. A.K. Davies would place a notice in the County Times and print some posters for the Concert.
